## CONTRACT OF SERVICES (Renewal)

## KNOW ALL MEN BY THESE PRESENTS

This contract is made and entered into by and between:

## WITNESSETH

WHEREAS, the FIRST PARTY is engaged not only in instruction but also in research and extension activities;

WHEREAS, the FIRST PARTY is grantee of research funds from other government agencies such as PCARRD, NSDB, DA and other private institutions;

WHEREAS, the **FIRST PARTY** is in need of personnel who possess the necessary technical; knowhow in the field of agricultural research; to conduct researches or assist the researcher in the conduct of research activities;

WHEREAS, the SECOND PARTY possesses the required technical knowhow in agricultural research and willing to participate in any research and development activities:

NOW, THEREFORE, premises considered, the parties hereto have hereunto agreed the following conditions to wit:

That the FIRST PARTY hires the services of the SECOND PARTY as Sci. Res. Asst. in project VCO.42.0183.1290.026/2 entitled Characterization of local and introduced coconut cultivars/hybrids effective Jan. 1, 1999 until June 30, 1999 unless sooner terminated.

That the SECOND PARTY has the following duties and responsibilities:

- To supervise the laborers in field data collection & field maintenance;
- 2) To do laboratory analysis;
- To assist the Study Leader in data organizing and report preparation

That in consideration of the SECOND PARTY, the FIRST PARTY binds itself to pay the former in the total amount of FIFTY SEVEN THOUSAND SEVEN HUNDRED NINE PESOS &.56 (P57,709.56) representing salary including ACA and PERA for six months net of 18 days service break, payable at least twice a month at ViSCA, Baybay, Leyte upon presentation of a certificate of service rendered duly attested by the representative of the FIRST PARTY

That the **SECOND PARTY** authorize the **FIRST PARTY** to deduct from the former's monthly salary the amount corresponding to personal contributions to GSIS term life insurance and medical insurance as provided by existing laws and regulations;
