

HOW TO ACCOMPLISH THIS FORM

1. Accomplish this form in triplicate Copies. Upon registration submit the original and duplicate copies to the Local Civil Registrar, and keep the third copy for your personal file.
2. Type or write legibly in ink on the blank spaces provided.
3. Fill up all items in this form completely and accurately.
4. For correctness and accuracy of data, the mother or the father shall be preferred as informant over any other person.
5. The informant shall be asked to sign item 14 of this form upon completion. Before doing so he should review the answers for each item and make sure that the entries made therein are all correct and that the name of the child as well as the names of the parents are correctly spelled.
6. Registration status refers to whether or not registration is delayed. If delayed, place '2' in box 15; otherwise '1'.

PENALTY CLAUSE OF ACT NO. 3753

Section 16 - False Statement - Any person who shall knowingly make false statements in the forms furnished and shall present the entry in the civil register, shall be punished by imprisonment for less than one month nor more than six, or by a fine not less than two hundred pesos nor more than five hundred or both, in the discretion of the court.

Section 17 - Failure to Report - Other Violations - Any person whose duty is to report any fact Concerning the civil status of persons and who knowingly fails to perform such duty, and any person convicted of having violated any of the provisions of this Act, shall be punished by a fine of not less than ten or more than two hundred pesos.

Section 18 - Neglect of Duty with Reference to the Provisions of this Act. Any Local civil registrar who fails properly to perform his duties in accordance with the provisions of this Act and of the regulations issued hereunder, shall be punished for the first offense, by an administrative fine in a sum equal to his salary for not less than fifteen days nor more than three month, and for a second or repeated offense, by removal from the service
