WHEREAS, the Grantee agrees to pursue graduate program without financial support from the University during the first year of her studies as she is not yet entitled to the fellowship, scholarship privileges as approved by the Board of Regents per BOR Res. No. 60, s. of 2009:

WHEREAS, the University is supporting the employee to great professionally,

NOW, THEREFORE, for and in consideration of the updual stipulations and conditions hereinafter contained, the parties do hereby agree as follows:

- 1. Subject to the terms and conditions stated below, the at University hereby allows the Grantee to go on Study Leave Grant effective on January 13, 2012 and to terminate on January 12, 2013 subject to the renewal for another year without the necessity of executing another contract to pursue a Master's degree in Engineering major in Industrial Engineering at the De la SalleUniversity, Metro Manila;
- The GRANTEE agrees and binds herself to:
 - a Pursue a Master's degree in Engineering major in Industrial Engineering for which this award is granted at De la Salle University, Metro Manil

- b. Conduct herself in a manner not to bring disgrams or dishonor to herself and or country and University;
- c. Take a full academic load every semester without changing her field of specialization without prior clearance from the Granter;
- d. Conform to all rules, regulations and laws of the institution she is attending and to such other regulations as may be duly prescribed by the Grantor in connection with the Study Leave:
- Maintain a semestral grade point average acceptable to the University where she is pursuing her graduate studies and of the mother agency;
- f. Submit progress of her studies and report of grades every semester,
- g. Return to VSU immediately upon completion of her degree and submit a written report on tudies within sixty (60) days after return to duty;
- h. Submit in 3 hard copies of approved thesis to:
 a) One (1) VSU Library. b) one (1) College library, and c) one (1) to the AACUP Center, upon return from study leave. One (1) copy in CD format must also be submitted to the VSU Library;
 - Serve VSU for a period of time at the rate of one year for every year or a fraction thereof not less than two months of enjoyment of the Grant within the Philippines or outside the Philippines, less than two months of enjoyment of said grant shall be served for half the rate. Provided, that failure to comply with the provisions of this paragraph or wilful abandonment of the grant, resulting to the noncompletion of the degree pursued shall obligate the GRANTEE to reimburse immediately in full to the GRANTOR all the expenses that the latter or the Philippine Government may have incurred including transportation, salaries and other expenses related thereto as well external financial grants given through or upon endorsement of the University in connection with her Grant plus an equity charge equivalen to 100% of the total amount expended, in which case shall not be less than P 5,000.00 and 14% interest per annum from the date of breach or revocation. It should be fully understood that refund shall in NO CASE proportionate allowed.
