GRADUATE RESEARCH/TEACHING ASSISTANTSHIP AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Agreement made and entered into by and between:

The Visayas State College of Agriculture (ViSCA), an institution of higher learning established under Presidential Decree No. 470 as amended by Presidential Decree 700 with principal office at Baybay, Leyte duly represented by the college President, Samuel S. Go, herein after referred to as the GRANTOR.

herein after referred to as the GRANTEE;

WITNESSETH:

WHEREAS, the Visayas State College of Agriculture has to promote staff development through Financial Assistance for graduate work in major fields of specialization;

WHEREAS, the GRANTEE has fully and satisfactorily met all the requirements as to qualification, standards and criteria set for Graduate Research/Teaching Assistantship grant;

NOW, THEREFORE, for and in consideration of the mutual stipulations and conditions herein after contained, the parties do hereby agree as follows:


1. Subject to the terms and conditions stated below, the College hereby awards to the Grantee, and the latter hereby accepts a Graduate Research/Teaching Assistantship grant charged to ViSCA effective on November 15, 1993 and to terminate on October 31, 1996 subject to renewal upon recommendation of the Graduate Research/Teaching Assistantship Screening Committee of the department/unit concerned and compliance with the pertinent provisions in the "Guidelines on Graduate Research/Teaching Assistantship" and for the completion of course/degree, to be pursued by the Grantee pursuant to and by virtue of this award, unless otherwise terminated earlier in accordance with this covenant. In case of an approved renewal of his/her Graduate Research/Teaching Assistantship, there shall be no more necessity for another instrument to be drawn.
2. The GRANTEE agrees and binds himself/herself to:
 - a. Pursue a graduate study course/degree in M.S. LT for which this award is granted in the department/office/center Arts and Letters.
 - b. Conduct himself/herself in a manner not to bring disgrace or dishonor to himself/herself and institution/or country;
 - c. Take a minimum academic load of 6 units every semester and 3 units for summer without changing his/her field of specialization without prior clearance from the GRANTOR; In cases where all the required graduate courses have been taken or courses are not offered during the summer term, the grantee shall be allowed to register only the thesis/dissertation.
 - d. Conform to all rules, regulations and laws of the institution he/she is attending and to such other regulations as may be duly prescribed by the GRANTOR in connection with the Graduate Research/Teaching Assistantship.

- e. Retain the Graduate Research/Teaching Assistantship throughout the period unless compelled to withdraw for urgent reasons and upon approval of the GRANTOR; Accept no other kind of Scholarship/Assistantship without clearance from ViSCA.
 - f. Receive a monthly compensation of ₱2,000/_____ for Master's, ₱3,000/_____ for doctoral degree, free tuition and comprehensive fees, and thesis/dissertation support not to exceed ₱10,000/_____ (subject to usual accounting and regulations).
 - g. Render service as Graduate Research/Teaching Assistant for a maximum of 20 hours per week. In cases where she/he cannot cope up with the required service hours, her/his salary shall be prorated.
 - h. Maintain a semestral weighted average grade of "2.00" or better. In the event that she/he gets a final grade of "5", she/he is automatically terminated. In no case shall he/she have incomplete grades in two courses per term.
 - i. Submit a copy of the thesis manuscript/doctoral dissertation to the Office of Graduate School and the ViSCA Library.
3. The GRANTEE shall forfeit or otherwise cease to be entitled to all benefits and privileges due him/her under this agreement should he/she fail to meet, comply or observe any of the obligations stipulated hereby and for other causes within his/her control like the following:
- a. Withdraw from the Agreement either during the life of the grant or during the period within which the Grantee shall have to render service to the Grantor;
 - b. Revocation of the grant by competent authority on account of the Grantee's conduct or behavior prejudicial to the College interests.
4. The GRANTOR binds itself to:


