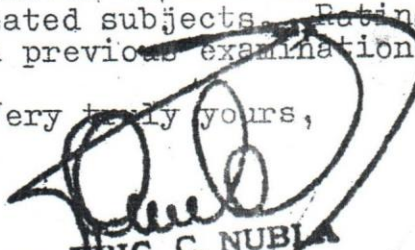

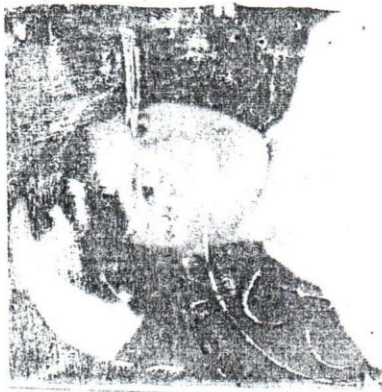

Provided, further, that an examinee taking a removal examination must obtain at least 75% in each of the repeated subjects. Ratings in red ink indicate subjects passed in a previous examination.

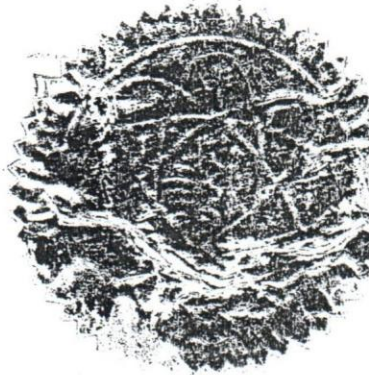

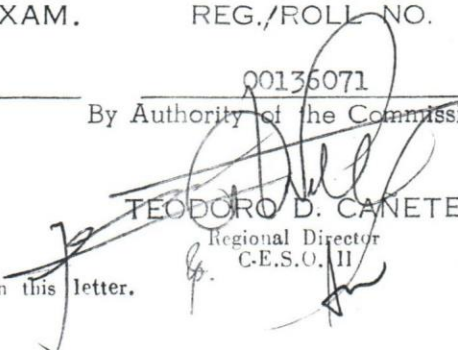

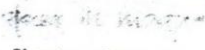
