

CONTRACT OF SERVICES

KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered into by and between:

The Visayas State College of Agriculture, the institution of higher learning established under Presidential Decree No. 470 as amended by Presidential Decree No. 700 with principal office at Baybay, Leyte, duly represented by the College President, SAMUEL S. GO hereinafter referred to as the FIRST PARTY

- and -

DALE P. LORETO of legal age, Filipino single and residing at M.L. Quezon St., Baybay, Leyte hereinafter referred to as the SECOND PARTY:

WITNESSETH

WHEREAS, the FIRST PARTY is engaged not only in instruction but also in research and extension;

WHEREAS, the FIRST PARTY is a grantee of research funded from other government agencies such as PCARRD, NSDB, MA, and other private institutions;

WHEREAS, the FIRST PARTY is in need of personnel and possess the necessary technical know-how in the field agricultural research to conduct researches or assist researchers in the conduct of research activities;

WHEREAS, the SECOND PARTY possess the required technical know-how in agricultural research and willing to participate in any research and development activities;

NOW, THEREFORE, premises considered, the parties hereof have hereunto agreed on the following terms and conditions to wit:

That the FIRST PARTY hires the services of the SECOND PARTY as Science Aide in Project Comprehensive Irrigation Research and Development Umbrella Program (CIRDUP) effective February 8, 1999 until June 30, 1999 unless sooner terminated;

That is the SECOND PARTY has the following duties and responsibilities:

1. To assist in the development of data collection instruments and their translation into the appropriate language or dialect.
2. To conduct interviews and collect and process primary and secondary data.
3. To assist encoding and in the analysis of the data.
4. To prepare project reports.
5. To perform other tasks that may be assigned by the research leader during the implementation of the study.

That in consideration of the services of the SECOND PARTY, the FIRST PARTY binds itself to pay the former a total amount P 38,876.00 (Thirty Eight Thousand Eight Hundred Seventy Six pesos only) representing salary including ACA and PERA for 1,000.00 mos. net of P 7,775.20, payable at least twice a month at ViSCA, Baybay, Leyte upon presentation of a certificate of service rendered duly attested by the representative of the FIRST PARTY;

That the SECOND PARTY authorizes the FIRST PARTY to deduct from the former's monthly salary the amount corresponding to personnel contributions to GSIS term life insurance and medical insurance as provided by existing laws and regulations;

That the SECOND PARTY agrees to the reservation of a right of the FIRST PARTY to terminate the services of the former in the event that the performance of the SECOND PARTY is prejudicial to the smooth and efficient operation of the FIRST PARTY in achieving the purpose of the project, for lack of funds, or for other just cause;

That in case either party desires to terminate this contract before its expiration date, a written notice shall be served to the other party at least thirty (30) days before effectivity of the termination.
