WITNESSETH

WHEREAS, the FIRST PARTY in engaged not only in Instruction but also in research and extension;

WHEREAS, the FIRST PARTY is a grantee of research funds from other government agencies such as PCARRD, NSDB, MA, and other private institutions;

WHEREAS, the FIRST PARTY is in need of personnel who posses the necessary technical know-how in the field of agricultural research to conduct researchers or assist the researchers in the conduct of research activities:

WHEREAS, the SECOND PARTY possess the required technical know-how in agricultural research and willing to participate in any research and development activities;

NOW, THEREFORE, premises considered, the parties hereto have hereunto agreed on the following terms and conditions, to wit:

unless sooner 'erminated:

That as the SECOND PARTY has the following duties and responsibilities:

- 1. Set-up polycross;
- 2. To set-up experiment related to breeding sweet potatos that are good in quality, high yield;
- 3. To do other functions that may be assigned by his supervisor.

That in consideration of the services of the SECOND PARTY, the FIRST PARTY binds itself to pay the former a total amount of Sixty thousand one hundred seventy nine pesos & 07/100 (\$\overline{20}\$, 179.07) representing salary including PERA and ACA for nine(9) months net of 20 days service break payable at least twice a month at VISCA. Baybay, Leyte upon presentation of a Daily Time Record duly attested by the representative of the FIRST PARTY:

That the SECOND PARTY authorizes the FIF.ST PARTY to deduct from his/her monthly salary the amount corresponding to his/her personal contributions to GSIS, RLIP, Medicare, ECIP and PAG-IBIG as provided for by existing laws and regulations;

That the FIRST PARTY grants the SECOND PARTY reimbursement of actual and necessary expenses for travels made officially in connection with the project and duly approved by the FIRST PARTY or his duly authorized representative upon presentation of pertinent supporting papers and subject to usual accounting and auditing rules and regulations;

That the SECOND PARTY is entitled to leave benefits as provide for by Joint CSC and DBM Circular No. 99-7 dated December 29, 1999. However, since monetization of leave credits and payment of terminal leave benefits of contractual employees are chargeable only to the lump sum appropriation of the current year of the agency the SECOND PARTY should enjoy all leave credits within the year it is earned.

That the SECOND PARTY agrees to the reservation of a right or the FIRST PARTY to terminate the services of the former in the event that the performance of the SECOND PARTY is prejudicial to the smooth and efficient operation of the FIRST PARTY in achieving the purpose of the project, for lack of funds, or for other just cause;

That in case either party desires to terminate this confract before its expiration date, a written notice shall be served to the other party at least (30) days before effectivity of the termination.
