KNOW ALL MEN BY THESE PRESENTS:

This agreement made and entered into by and between:

The Visayas State University (VSU) formerly the Leyte State University (LSU), which was renamed from LSU to VSU by virtue of R.A 9437 with principal office at Baybay City, Leyte, duly represented by the University President, **Dr. EDGARDO E. TULIN** hereinafter referred to as the **GRANTOR**;

-and-

**Engr. JIMMY O. POGOSA**, of legal age, single, Filipino, with residence and postal address in Brgy. Marcos, Baybay City, Leyte hereinafter referred to as the **GRANTEE**;

**WITNESSETH**

WHEREAS, the Visayas State University has to promote staff development through Scholarship, Fellowship or Financial Assistance for graduate/post graduate work in major fields of specialization including attendance to conferences, workshops and on-the-job trainings;

WHEREAS, the Visayas State University received an invitation letter to do research at Bern University, Switzerland in the context of the Swiss National Science Foundation Project "COCOBOARDS: environmentally sound technology for the manufacturing of affordable building materials based on coconut husk and natural bonding agents" from April 1, 2016 to May 31, 2016;

WHEREAS, the GRANTEE has fully and satisfactorily met all the requirements as to qualification, standards and criteria set for the **Grant**;

NOW, THEREFORE, for and in consideration of the mutual stipulations and conditions hereinafter contained, the parties do hereby agree as follows:

1. That the Grantee shall keep up with the standards of the training fellowship or award;
2. That the Grantee shall conduct himself in a manner as not to bring disgrace or dishonor to himself and/or his institution;
3. That the Grantee shall submit to the head of his agency and to the other concerned offices a completion report of his research within sixty (60) days after his return to duty;
4. That the Grantee shall be return immediately and report to his office upon the completion or termination of his training;
5. That the Grantee shall serve his Agency at the rate of one (1) year for every year of enjoyment of the grant. A fraction of a year will be counted as one year. Failure to comply with the service requirement will oblige the Grantee to pay in money value of the unserved portion of the grant,

6. The **GRANTOR** binds itself to pay the grantee during the period of the training:


- a. salaries


