TRAINING/SCHOLARSHIP CONTRACT OF AGREEMENT

The Farming Systems Development Project - Eastern Visayas, award a scholarship to PASTOR P. GARCIA, SR. to enable him/her to undertake a Degree Training program in MS in Agricultural Engineering (Degree or Non-degree) at the UPLB effective June, 1988 (Date) for a duration of 2 years, subject to terms and conditions of this contract:

1) That the Farming Systems Development Project - Eastern Visayas thru the Ministry of Agriculture, Region 8/Visayas State College of Agriculture will provide the grantee with the following monetary assistance for the duration of the scholarship, the release of which shall be programmed with the enumeration of the purposes of the expenses and is subject to availability of funds and auditing rules and regulations:

- Matriculation and other School fees
- Monthly allowance of P 1,200.00
- Book/School Supply allowance at P 600.00 per semester and P 300.00 per Summer.
- Thesis assistance of P 10,000.00 to be provided on installment basis.
- Graduation expenses including diploma, alumni fees, memorabilia and rent of toga up to a maximum of P 200.00 to be reimbursed by the Farming Systems Development Project - Eastern Visayas to the grantee upon presentation of receipts.
- Group accident insurance to be provided by the Farming Systems Development Project - Eastern Visayas.
- Travelling expenses and per diems to and from the place of residence or official station at the start and ending of the school year.

2) That the Farming Systems Development Project - Eastern Visayas thru the Ministry of Agriculture, Region 8/Visayas State College of Agriculture shall reserve the right to terminate this contract within one month in written notice to the grantee. The College of Agriculture and/or to the grantee, termination of scholarship will be based on any of the following conditions:

- The grantee fails to meet the academic standards set hereunder or to live up to the terms and conditions of his/her grant.
- The grantee will fully fails to enroll or drops his/her courses without his/her school, agency, and the Farming Systems Development Project - Eastern Visayas approval.
- The grantee commits gross misconduct; or



d) Lack of funds

3) That he/she shall devote full time to his/her program of study and keep up with the necessary standards of scholarship accomplishment and finish the program within the allotted period of two (2) years for M.S. and three (3) years for Ph.D.;

4) That, in case he/she won't be able to finish his/her program within the prescribed period indicated in the contract, an extension maybe given based on meritorius reasons though all monetary assistance will be cut off but monitoring by the Ministry of Agriculture, Region 8, and Farming Systems Development Project-Eastern Visayas/Visayas State College of Agriculture would continue;

5) That he/she shall not leave his/her program without prior approval of the school, agency and/or Farming Systems Development Project-Eastern Visayas;

6) That he/she shall work for a thesis on problem existing in the region with aim in view that the finding may be used to improved the livelihood of the small farmers in upland areas in Region VIII. He/she shall provide the Farming Systems Development Project-Eastern Visayas/Visayas State College of Agriculture, Region 8, with copies of his/her thesis;

7) That he/she shall maintain a general average of 2.0 or higher throughout his/her scholarship. In case the scholastic requirements of the school or training agency is higher, then these standards would prevail;

8) That he/she shall conduct himself/herself in such a manner as not to bring disgrace or dishonor to himself/herself and or his/her office/country;

9) That he/she shall submit to the Farming Systems Development Project-Eastern Visayas/Visayas State College of Agriculture and the Ministry of Agriculture, Region 8, progress reports, as follows:

I. <u>Degree Program Reports</u>	<u>Submission Period</u>
a. Xerox copy of registration form	Immediately after registration
b. Semestral/Summer Progress Reports indicating subjects taken and grades obtained	On/or before the start of the next term immediately following the term being reported
c. Preliminary Plan of Coursework as approved by the adviser	Sixty (60) days after the start of classes for the first term following the award of scholarship
d. Approved list of Guidance Committee	Before the start of the second term of enrolment
e. Approved Plan of Coursework (as approved by the Guidance Committee)	Before the end of the second term of enrolment
f. Approved Thesis Outline (as approved by the Guidance Committee)	Before the end of the last semester it is enrolled
g. Results of the Qualifying Examination (for Ph.D.)	Two (2) weeks after examination
h. Results of the Comprehensive Examination	Two (2) weeks after examination

10) That he/she shall return and report immediately to his/her office upon the termination of his/her scholarship, fellowship, training, or study grant;

11) That upon completion of his/her scholarship program, he/she shall serve the Ministry of Agriculture, Region 8/Visayas State College of Agriculture along the field of his/her specialization or training, for a period of not less than three (3) years for every year or a fraction thereof or not less than two (2) months of his/her scholarship for degree and non-degree program. When the scholarship is for a period of two (2) months or less he/she shall render service for only one (1) year;

12) That he/she shall make his/her services available to the Farming Systems Development Project-Eastern Visayas, and that if he/she is not connected with the project, he/she will serve this project on a consultative basis;

13) That he/she shall refund two (2) folds to the Ministry of Agriculture/Visayas State College of Agriculture such sums of money that may have been defrayed for his transportation, salary, allowance and other expenses including those spent by the host country or sponsoring organization/incident to his/her scholarship, training or study grant for:

- a. Failure to render, in full or in part, the required length of service as stipulated in this contract on account of voluntary resignation, retirement, separation from the service through his own fault, or other cause within his/her control; or
- b. His/her having been recalled following cancellation of his/her scholarship, or study grant due to his own fault or willfull neglect pursuant to conditions under 3, 7, as set forth above.
- c. Violation of any provisions of the scholarship training contract.
