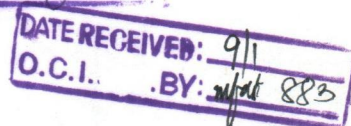
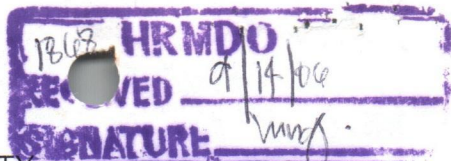

The above-named faculty-employee is cleared of money, property and other responsibilities from the LSU, Visca, Baybay, Leyte as indicated below:

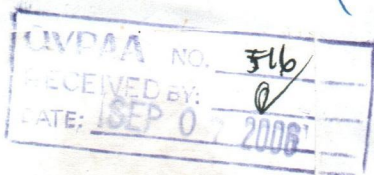
