Ms. Ivy C. Emnace, of legal age, married, Filipino and residing at VSU Campus, Baybay City, Leyte hereinafter referred to as the **SECOND PARTY**:

WITNESSETH:

WHEREAS, the **FIRST PARTY** is in need of one who will teach Ftec 132, 152, HRTM 22 courses/subjects at the Department of Food Science & Technology, VSU, Baybay City, Leyte effective 2nd Semester, SY 2007-2008 for a maximum of 275 contact hours required for this semester at P 150.00 per hour and not to exceed the monthly salary of an equivalent regular position.

The amount shall be taken from Lump Sum appropriation for honoraria, payable on a monthly basis based on the actual number of hours served as certified by the Department Head.


That this agreement will not in any manner result to any employer-employee relationship between the parties.






