**II. Psychopathological Indicator**

**Basic Personality Inventory (BPI)**

The Basic Personality Inventory (BPI) Test is a personality test that is used to apprise a number of broad facets of personality and psychopathology both within the normal population and within the population of persons experiencing psychological distress. The said test contains twelve (12) scale descriptions which are the following: Hypochondriasis; Depression; Denial; Interpersonal Problems; Alienation; Persecutory Ideas; Anxiety; Thinking Disorder; Impulse Expression; Social Introversion; Self Depreciation; and Deviation.

The client's result showed **normal pattern** of elevation in most of the domains. However, she indicated a **low** elevation on **Impulse Expression** domain which signifies that she is likely even-tempered and level-headed. She may carefully consider the future before acting. Generally, she has the patience to cope with a lengthy and tedious task. Similarly, she noted a **low** elevation on **Deviation** domain which entails that she generally shows behavior patterns similar to those of a majority of people. She tends to be free from unusual symptoms and modes of thought.

**Comments/Recommendation:**

Overall results of the tests show that the client has no psychopathological indicator seen at the time of the evaluation. She may qualify for the position that she is applying for.

**General Data:**

**Past Medical History:**

She had polycystic ovarian syndrome in 2017. She had endometrial cyst in 2023. She is non-hypertensive, non-diabetic, and non-asthmatic. She has no known food and drug allergies. She has no history of psychiatric illness and no learning disability.

**Family History:**

Heredofamilial diseases include hypertension on both parental sides, cardiac problems on the paternal side, and breast cancer & colon cancer on the maternal side.
