That the FIRST PARTY hires the services of the SECOND PARTY as Sci. Res. Asst. in project VCO.42.0183.1290.026/2 entitled Characterization of local and introduced coconut cultivars/hybrids effective July 1, 1999 until December 31, 1999 unless sooner terminated.

That the SECOND PARTY has the following duties and responsibilities:

- 1) To supervise the laborers
- To gather growth data and local hybrids subjected under (3) levels of fertilization planted in Brgy. Marcos;
- 3) To compile thos data gathered for mid-year and year end reports
- 4) To do other jobs that maybe assigned by her superior
