KNOW ALL MEN BY THESE PRESENTS:

This contract entered by and between:

Mindanao State University-ILIGAN INSTITUTE OF TECHNOLOGY, a government university with office address at A. Bonifacio St., Tibanga, Iligan City, herein represented by MARCELO P SALAZAR, Chancellor, herein referred to as the "First Party" and BERNA LOUL ABA, of legal age and a resident of ILIGAN CITY, herein after referred to as the "Second Party".

WITNESSETH

The First Party is in need of the services of the Second Party who shall perform work not performed by the regular personnel of the First Party;

That the Second Party has signified his/her intention to which the First Party has accepted to provide services needed by the latter;

That the Second Party hereby possesses the education, experience and skills required to perform the job as described herein;

That the Second Party hereby attests that he/she is not related within the third degree (fourth degree in case of LGUs) of consanguinity or affinity to the (1) hiring authority and/or (2) representative of the First Party, has not been previously dismissed from government service by reason of an administrative offense, that he/she has not already reached the compulsory retirement age of sixty-five (65);

That in view hereof, the Second Party is hereby contracted as ASST. PROF. IV for the period of 1st Semester beginning 06-01-10 and terminating on 10-31-10, in consideration of a daily rate of ONETHOUSAND AND NINE AND 73/100 pesos (P1009.73), to be paid on a monthly basis.

That as ASST. PROF IV The Second Party is expected to perform the following functions:

That the Second Party shall perform works at a time and schedule to be agreed upon by both parties;

That it is understood that this contract creates an employer-employee relationship between the parties, that the services rendered hereunder are considered and will be accredited as government service, and that the latter is entitled to benefits enjoyed by the regular personnel of the First Party (CSC-DBM Joint Circular No. 99-7).
