This Memorandum of Agreement made and entered into by and between:

The VISAYAS STATE UNIVERSITY (VSU), formerly the LEYTE STATE UNIVERSITY, an institution of higher learning established under Presidential Decree No. 470 as amended by Presidential Decree No. 700, and converted into a state university by virtue of RA 9158, with principal office at Visca, Baybay City, Leyte duly represented by its President, DR. JOSE L. BACUSMO, hereinafter referred to as the mother agency of the seconded employee, Prof. FRANCISCO G. GABUNADA, JR. as Party of the First Part;

The PHILIPPINE CARABAO CENTER (PCC), Department of Agriculture a government agency with principal office at National Gene Pool and Headquarters Science City of Muñoz, Nueva Ecija, created under Republic Act No. 7307, otherwise known as the Philippine Carabao Center Act of 1992, represented by DR. LIBERTADO C. CRUZ, Executive Director, employee Prof. FRANCISCO G.GABUNADA, JR. as Party of the Second Party;

WITNESSETH:

WHEREAS, the VSU and PCC recognize the importance of cooperative effort in the implementation and coordination of the Carabao Program by virtue of Section 12, Republic Act No. 7307, enacted on March 27, 1992;

WHEREAS, both parties recognize that in order to properly deliver the mandate of PCC, the Agricultural Center Chief IV should work full time;

WHEREAS, Rule VII, Section 9 of the Civil Service Commission, Omnibus Rules Implementing Book V of Executive Order No. 292 of said Commission provides that: "Secondment is a movement of an employee from one department or agency to another which is temporary in nature and which may not require issuance of an appointment but may either involve reduction or increase in compensation";

WHEREAS, Prof. FRANCISCO G. GABUNADA, JR., seconded to PCC at VSU to serve as the Center's Agricultural Center Chief IV with a monthly salary of P31,334.00 and P500.00 personal relief allowances (PERA), P1,500.00 additional compensation and P8,000.00 as monthly Representation and Transportation Allowance (RATA);

NOW, THEREFORE, for and in consideration of the above premises hereto stipulate, covenant and agree that the secondment of Prof. Francisco G. Gabunada, Jr.. from VSU to PCC shall be renewed effective June 01, 2010 to May 31, 2011 unless otherwise terminated by the receiving agency (PCC) for cause, provided that PCC shall pay the salary, bonuses and other remuneration of Prof. Francisco G. Gabunada, Jr., subject to PCC guidelines, during the period of his secondment.
