To pass the Licensure Examination for Agriculturists, a candidate must obtain a weighted general average grade of at least seventy-five (75%) percent with no grade lower than sixty (60%) percent in any given subject. An examinee who obtains a weighted general average grade of seventy-five (75%) percent or higher but obtained a rating below sixty (60%) percent in any given subject/s may be allowed to take a removal examination in the subject/s where he obtained a grade below sixty (60%) percent. The removal examination shall be allowed only once.
- 3. An examinee who fails to pass the examination for the third time shall be allowed to take another examination only after said examinee has taken a six months refresher course in the field/s of specialization in Agriculture where he/she failed once, twice or three times organized by a school or college of Agriculture established or recognized by the Government. The three-time flunker shall not be allowed to take the examination unless he/she presents or submits a certification under oath issued by the authorized official of the school or college of Agriculture certifying that the three-time flunker has successfully completed the refresher course. For purposes of determining the three (3) failures, the first examination and the removal examination shall be considered as one examination.
