CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

This agreement made and entered into by and between:

The Visayas State University formerly the Leyte State University (LSU), which was renamed from LSU to VSU by virtue of R.A 9437 with principal office in Baybay City duly represented by the University President, **DR. JOSE L. BACUSMO** hereinafter referred to as the **GRANTOR**;

-and-

JEDESS MILADEL C. NUNEZ, of legal age, Filipino, single with residence and postal address in **VSU - Main Campus, ViSCA, Baybay, City, Leyte** hereinafter referred to as the **GRANTEE**;

WITNESSETH

WHEREAS, the Visayas State University has to promote staff development through faculty Scholarship, Fellowship or Financial Assistance for graduate/post graduate work in major fields of specialization;

WHEREAS, the Visayas State University is willing to support the staff who failed to get a scholarship from the University by including them for outside scholarships;

WHEREAS, the **Grantee** has secured a scholarship from an outside grantor;

NOW, THEREFORE, for and in consideration of the mutual stipulations and conditions hereinafter contained, the parties do hereby agree as follows:


1. Subject to the terms and conditions stated below, the University hereby allows the **Grantee** to go on Study Leave without pay effective on **February 16, 2010** and to terminate on **February 15, 2011** subject to the renewal upon recommendation of the VSU Scholarship Committee and compliance with the pertinent provisions of this Contract for the completion of a **Master's degree in Applied Anthropology and Participatory Development** to be pursued by the **Grantee** pursuant to and by virtue of this award. In case of an approved extension of *her Study Leave* beyond the period specified in this contract, there shall be no more necessity for another contract to be drawn.
2. The **GRANTEE** agrees and binds *herself* to:
- Pursue a **Master's degree** in which this award is granted at the **Australian National University, Canberra, Australia.**
 - Conduct *herself* in a manner not to bring disgrace or dishonor to *herself* and/or country and University;
 - Take a full academic load every semester without changing *her* field of specialization without prior clearance from the **GRANTOR**;


- d. Conform to all rules, regulations and laws of the institution *she* is attending and to such other regulations as may be duly prescribed by the **GRANTOR** in connection with the **Grant**;
- e. Maintain a semestral grade point average acceptable to the University where *she* is pursuing *her* graduate studies and of the mother agency;
- f. Return to VSU immediately upon completion of *her* studies (2 yrs & 5 mos. for MS and 3 yrs and 5 mos. for Ph.D. degree) and submit a written report on *her* studies within sixty (60) days after return to duty. Request for extension is subject to University approval.
- g. Submit a copy of the thesis manuscript to the VSU Library;
- h. Serve VSU for a period of time at a rate of one year for MS and two years for Ph.D. program. Provided, that failure to comply with the provisions of this paragraph shall obligate the **Grantee** to pay the University as damages an amount equivalent to *her* one (1) year salary for MS and two (2) years for Ph.D. degree. The amount will be based on the most recent salary schedule of the equivalent position occupied by the scholar.




