This contract is made and entered into by and between:

and

WITNESSETH

WHEREAS, the FIRST PARTY is engaged not only in instruction but also in research and extension activities;

WHEREAS, the FIRST PARTY is grantee of research funds from other government agencies such as PCARRD, NSDB, DA and other private institutions;

WHEREAS, the **FIRST PARTY** is in need of personnel who possess the necessary technical; knowhow in the field of agricultural research; to conduct researches or assist the researcher in the conduct of research activities;

WHEREAS, the **SECOND PARTY** possesses the required technical knowhow in agricultural research and willing to participate in any research and development activities;

NOW, THEREFORE, premises considered, the parties hereto have hereunto agreed the following conditions to wit:

That the FIRST PARTY hires the services of the SECOND PARTY as Sci. Res. Asst. in project VCO.40.0187.1298.074 entitled on the Development of self pollinating and precocious macapuno palms using three highly selfed dwarf coconut cultivars/hybrids effective July 1, 1998 until December 31, 1998 unless sooner terminated.

That the SECOND PARTY has the following duties and responsibilities:

- To supervise laboratory and field activities
- To gather ad organize pertinent data
- 3) To assist the Study Leader in report preparation
- 4) To do other activities related to the conduct of the study

That the SECOND PARTY authorize the FIRST PARTY to deduct from the former's monthly salary the amount corresponding to personal contributions to GSIS term life insurance and medical insurance as provided by existing laws and regulations;

And Andries Helbermanny of Hound

That the FIRST PARTY grants the SECOND PARTY reimbursement of actual and necessary expenses for travel made officially in connection with the project and duly authorized representative upon presentation of pertinent supporting papers and subject to usual accounting and auditing rules and regulations;

That the SECOND PARTY agrees to the reservation of a right of the FIRST PARTY to terminate services of the former in the event that the performance of the SECOND PARTY is prejudicial to the smooth and efficient operation of the FIRST PARTY, in achieving the purpose of the project, for lack of funds, or for other just cause;
