That the FIRST PARTY bires the services of the SECOND PARTY as Sci. Research Assistant in the Project NRCCTP Project Wational RootcCrop

Cooperative Testing Program"

effective January 1, 2001 until June 30, 2001

unless sooner terminated:

That as the SECOND PARTY has the following duties and responsibilities:

1. To assist the project/study leader on the following activities related to NRCCTP;
a. Conducting preliminary/advance trials to identify cultivars for entry in NRCCTP;

b. Setting-up of field for multiplication of materials in sweetpotato

c. Setting-up and supervision of experiment on cooperating station throughout the Philippines; and

d. Collection and analysis of data;

2. To do other duties that may be assigned by the supervisor.

That in consideration of the services of the SECOND PARTY, the FIRST PARTY binds itself to pay the former a total amount of FIFTH FIVE THOUSAND THREE HUNDRED SIXTEEN PESOS & 22/100(255.316.22) representing salary including PERA and ACA for six(6) months net of twelve(12)days service break payable at least twice a month at VISCA Baybay. Leyte upon presentation of a Daily Time Pecord duy attested by the representative of the FIRST FARTY;

That the SECOND PARTY authorizes the FIRST PARTY to deduct from his/her monthly salary the amount corresponding to his/her personal cortributions to GSIS, RLIP, Medicare, ECIP and PAG-IBIG as provided for by existing laws and regulations;

That the FIRST PARTY grants the SECOND PARTY reimbursement of actual and necessary expenses for travels made officially in connection with the project and duty approved by the FIRST PARTY or his duty authorized representative upon presentation of pertinent supporting papers and subject to usual accounting and auditing rules and regulations;

That the SECOND PARTY is entitled to leave benefits as provide for by Joint CSC and DBM Circular No. 99-7 dated December 29, 1999. However, since monetization of leave credits and payment of terminal leave benefits of contractual employees are chargeable only to the lump sum appropriation of the current year of the agency the SECOND PARTY should enjoy all leave credits within the year it is earned.

That the SECOND PARTY agrees to the reservation of a right or the FIRST PARTY to terminate the services of the former in the event that the performance of the SECOND PARTY is prejudicial to the smooth and efficient operation of the FIRST PARTY in achieving the purpose of the project, for lack of funds, or for other just cause;

That in case either party desires to terminate this confract before its expiration state, a written notice shall be served to the other party at least (30) days before effectivity of the termination.
