

TEACHING AGREEMENT ON PER HOUR BASIS

KNOW ALL MEN BY THESE PRESENTS:

This agreement made and executed into by and between:

The Visayas State University (VSU) formerly the Leyte State University (LSU), which was renamed from LSU to VSU by virtue of R.A. 9437 with principal office at Baybay, Leyte duly represented by the OIC, College Dean, Dr. WINSTON M. TABADA hereinafter referred to as the FIRST PARTY;

Ms. Jonah Flor V. Oraño, of legal age, single, Filipino and residing at VSU Campus, Baybay, Leyte hereinafter referred to as the SECOND PARTY:

WITNESSETH:

WHEREAS, the FIRST PARTY is in need of one who will teach CS 21, 101, 141, HRTM 135 courses/subjects at the Department of Computer Science & Technology, VSU Campus, Baybay, Leyte effective 1st Semester, SY 2007-2008 for a maximum of 456.50 contact hours required this semester at P 100.00 per hour and not to exceed the monthly salary of an equivalent position.

That for and in consideration of the foregoing job, the FIRST PARTY agrees to pay the SECOND PARTY the required total number of hours of service as certified to by the Department Head duly conformed by the Registrar to ensure that hours served are in accordance with the prescribed schedule of classes, the amount shall be taken from Lump Sum appropriation for honoraria, payable after the end of the month.

That this agreement will not in any manner result to any employer-employee relationship between the parties.
