## **REASON FOR REFERRAL**

Joy Adeline was referred for psychological evaluation as a pre-requisite for her application as Science Research Specialist I.

#### **BACKGROUND INFORMATION**

Joy Adeline was born as the third (3rd) child among four children of Elmer Nunez and Tessie Nunez. Her parents separated because her father had an extra-marital affair with another woman. Before separation, she observed her parents were always quarreling. Siblings were not close to their father. According to her, their mother was the only person who guided them as they progressed in their studies. Her mother, Tessie Nunez, is a retired professor from Visayas State University. She is married to Earl Hanson Cadalin, a farm manager in Tacloban City. She recalled that their parents raised them in traditional ways, such as punishing them whenever they did wrong. However, they were also asked to explain the reason for doing it. She described herself as an organized and goal-oriented person. She completed her college degree in 2013 at Visayas State University in Baybay City, Leyte. During high school, she used to get involved in many organizations.

# **BEHAVIORAL OBSERVATIONS**

Joy Adeline came to interview appropriately dressed. She was calm, cooperative and attentive. She was observed reserved. She spoke in a soft and low tone of voice. Her ideas were clear. She spoke spontaneously and answered questions appropriately. She was oriented to time, place and person. Memories as to recent, immediate and remote were intact.

Her mood was euthymic and her affect was congruent. They were no thoughts or perceptual disturbances during the entire interview. Her judgment and insights were good. Her concentration and calculation were also noted as good.

#### **TEST INTERPREPATION**

Sacks Sentence Completion Test was administered to determine significant information relevant to the person's representative areas of adjustment: family, interpersonal relationships, sex, and self-concept. Results show that Joy is family-oriented. However, she manifested a significant disturbance regarding his relationship with his father. She hopes her father to become healthier, and be focused on setting priorities. Moreover, she bears guilt feelings regarding her academic performance in high school and college. She regrets that she did not perform well in school before. Nevertheless, she is optimistic about the future and confident with her abilities at work.

House-Tree-Person Test was given to provide information about her general conflicts and concerns, as well as specific aspects of the environment that she finds troublesome. Joy's illustrations reflect meticulousness and need for precision. She also seeks satisfaction in intellectual areas. However, she tends to be highly anxious. In terms of her relationship with others, she is reserved and has tendencies to withdraw.

#### **REMARKS**

Based on the current results, Joy appears to have significant disturbances regarding his relationship with his father and her previous academic performance. She also has tendencies to be highly anxious. Nevertheless, she did not manifest any problems with her relationships with other people. She also maintains self-efficacy, which will help her in accomplishing difficult tasks in the future.
