Go, hereinafter referred to as the FIRST PARTY;

FATIMA T. BALIMA of legal age, Filipino, single and residing at VISCA, Baybay, Leyte hereinafter referred to as the SECOND PARTY.

WITNESSETH

WHEREAS, the FIRST PARTY is engaged not only in instruction but also in research and extension activities:

- Serve as contact person of the CFTU Secretariat. Perform other functions as designated by the Director.

That for and in consideration of the foregoing services, the FIRST PARTY binds itself to pay the SECOND PARTY a total amount of SIXTY-FOUR THOUSAND EIGHTY-TWO PESOS & 40/100 only (P64,082.40) representing SIX-MONTHS salary, including ACA and PERA; payable at least twice a month at ViSCA, Baybay, Leyte upon presentation of tertificate of service rendered duly attested by a representative of the FIRST PARTY chargeable to the general representative of the FIRST PARTY, chargeable to the general fund appropriation of FARMI;

That the FIRST PARTY grants the SECOND PARTY reimbursements of transportation and per diem allowances for official travels made in connection with the project and duly approved by the FIRST PARTY or his duly authorized representative upon presentation of pertinent supporting papers and subject to usual accounting rules and regulations;

That the FIRST PARTY reserves the right to terminate the services of the SECOND PARTY for reasons of poor performance, for conduct prejudicial to the smooth and efficient operation of the project, for lack of funds, or for any other just cause;
