

CONTRACT OF SERVICES

KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered into by and between:

The Visayas State College of Agriculture, an institution of higher learning established under Presidential Decree No. 470 as amended by Presidential Decree No. 700 with principal office at Baybay, Leyte, duly represented by the College President, Dr. SAMUEL S. GO, hereinafter referred to as the FIRST PARTY;

- and -

PAULINE C. SALIGUE of legal age, Filipino Single and residing at ViSCA, Baybay, Leyte hereinafter referred to as the SECOND PARTY:

W I T N E S S E T H

WHEREAS, the FIRST PARTY is engaged not only in instruction but also in research and extension activities;

WHEREAS, the FIRST PARTY is a grantee of research funds from other government agencies such as PCARRD, NSTA, DA, and other private institutions;

WHEREAS, the FIRST PARTY is in need of personnel who possess the necessary technical know-how in the field of agricultural research to conduct researches or assist the researchers in the conduct of research activities;

WHEREAS, the SECOND PARTY possesses the required technical know-how in agricultural research and willing to participate in any research and development activities;

NOW, THEREFORE, premises considered, the parties hereof have hereunto agreed on the following terms and conditions to wit:

That the FIRST PARTY hires the services of the SECOND PARTY as Science Research Specialist I in Project Trust 8-84-100-2.1 [Affiliated Nonconventional Energy Center (ANEC) for Biliran and Leyte Provinces] effective July 1, 1998 until December 31, 1998 unless sooner terminated;

That the SECOND PARTY has the following duties and responsibilities:

1. In-charge of overall extension/promotional activities of the project;
2. Prepare radio plugs, press releases, and other promotional activities on NES;
3. Conduct NES trainings, energy fora, seminars, workshops;
4. In-charge of the energy database and other office documents;
5. Monitor fuel prices and electricity rates in Biliran province;
6. Conduct impact assessment studies on NES;
7. Prepare quarterly accomplishment reports, financial reports, and other reports for submission to funding agency;
8. Prepare proposals on promotional activities for funding; and
9. Do other duties assigned by the project director.

That in consideration on the services of the SECOND PARTY, the FIRST PARTY binds itself to pay the former a monthly salary of Twelve Thousand Two Hundred Ninety-Seven pesos & 60/100 (P12,297.60) plus P500.00 ACA and P500.00 PERA payable at least twice a month at ViSCA, Baybay, Leyte upon presentation of a certificate of service rendered duly attested by the representative of the FIRST PARTY;

That the SECOND PARTY authorizes the FIRST PARTY to deduct from the former's monthly salary the amount corresponding to personnel contributions to GSIS term life insurance and medical insurance as provided by existing laws and regulations;

That the FIRST PARTY grants the SECOND PARTY reimbursement of actual and necessary expenses for travels made officially in connection with the project and duly approved by the FIRST PARTY or his duly authorized representative upon presentation of pertinent supporting papers and subject to usual accounting and auditing rules and regulations;

That the SECOND PARTY agrees to the reservation of a right of the FIRST PARTY to terminate the services of the former in the event that the performance of the SECOND PARTY is prejudicial to the smooth and efficient operation of the FIRST PARTY in achieving the purpose of the project, for lack of funds, or for other just cause;


That in case either party desires to terminate this contract before its expiration date, a written notice shall be served to the other party at least thirty (30) days before effectivity of the termination.






