BACKGROUND HISTORY

This is a 26-year-old Male, Married, Right-handed Filipino who was seen today at the clinic for consultation for a neuropsychiatric examination—no chief complaints in terms of Neurological or Psychiatric issues.

He has no known comorbidities- nonhypertensive, nondiabetic, and nonasthmatic. No other maintenance medications or herbal capsule use. He was hospitalized twice in his Elementary School years due to pneumonia and amebiasis. Currently, patient has no vices but once smoked and drank alcohol when he was still in college. No herbal medications. Family history of diabetes mellitus in the paternal side.

The patient was never hospitalized for any neurologic problems. Upon neurologic review of systems, he has no history of headaches, memory loss, vertigo, lightheadedness, hearing loss, diplopia, blurred vision, blindness, anosmia, loss of taste, facial weakness, dysarthria, dysphagia, muscle weakness, sensory loss, back pain, or any bladder or bowel complaints.

He never had any previous laboratories or neuroimaging. He had a previous Neuropsychiatric examination last 2020 when he applied as a Reserve Officer for the Philippine Army last 2020, which patient claimed was unremarkable and normal.

The patient denies any consultation with a psychiatrist in the past. He had no symptoms of unusually depressed or elevated mood, hallucinations, delusions, or illusions.

BEHAVIORAL OBSERVATIONS AND MENTAL STATUS EXAM

Observations

The patient arrived by himself at the designated clinic time. He was casually dressed and groomed, well-kempt, alert, oriented, and interactive. He was ambulatory. Demeanor was professional and cooperative. Language functions were grossly intact for expressive and receptive modalities. Thought processes were clear and goal-directed, with content of thought appropriate to the situation. Mood was euthymic with a normal affective range. Observation of upper extremity motor behavior revealed no obvious difficulty or asymmetry. No apparent tactile sensory loss was noted, and no auditory or visual difficulties impacted test administration. Cooperation and motivation were appropriate. Insight, awareness, and judgment were fair.

Mental Status Examination

The Mini-Mental Status examination was 30/30, without any deficits in all the tested cognitive domains. The patient was oriented to time, place, and person.

CLINICAL INTERVIEW

Developmental Factors

As far as he can recall, the patient had no problems during the prenatal, natal, and postnatal period. His development was at par with age.

Emotional, Personality, and Background Factors

He grew up with his parents as an only child. He was an achiever when he was in elementary school, graduating first in his class at Carlos P. Garcia Elementary School in Baybay City.

He went to high school in Visayas State University Laboratory High School. He mentioned that he initially lost his confidence because his peers were from more prominent elementary schools. He said he experienced verbal bullying during his early high school years and his coping mechanism was immersion in computer games, where he met his current set of close friends. Until now, he is still meeting every now and then with his high school friends. Since high school until his college days, he lived in a dormitory set-up, which taught him how to live independently.

He went to college at Visayas State University (VSU)- Baybay City and took up Bachelor of Science in Agriculture. He was a scholar of the Department of Science and Technology (DOST). Patient said that in his college years he gained more friends and can describe nothing significantly negative about his college years. He graduated from the same institution in 2020.

After graduating, initially he aimed to train as a reserve officer in the Philippine Army post in Catbalogan City, Samar but he did not pursue. The then decided to work as a teacher under the Department of Education in Brgy. Palompon, Baybay Ciy, Leyte as return of service (ROS) for his DOST scholarship. He worked in this institution to fulfill his requirements for the ROS but set a goal to find another job after the ROS. His workplace in Palompon was a bit toxic, according to the patient, where some workmates have a tendency to criticize another workmate but does not tell directly the person involved, in a way that is quite unprofessional. He was regularized in this position last 2023, and since his start he had the same set of friends in the workplace.

He was contacted the previous year by his teacher in the College of Economics in VSU-Baybay for an opening as Instructor I. His thoughts towards the job opening are that "if it's for me, it's for me", and prayed to God if that job is really meant for him. Earlier this year 2025 he visited the VSU campus and found that the position offered was still vacant, thus applied for and the reason for the current requirement for the neuropsychiatric exam. His goal if employed in VSU is to establish his name in the university, and pursue a Master's Degree in his chosen field, as some of his peers were offered scholarships abroad which inspired him to pursue the same goals.

He was also recently married last November 2023 and currently living with his wife and father. He currently still has no child with his wife. There currently are living harmoniously at home without any major interpersonal conflicts.

SUMMARY AND IMPRESSIONS

This was a 26-year-old, married, right-handed Filipino male who was seen for a neuropsychological evaluation as a prerequisite for employment as a Instructor I in a government-run University. His history did not reveal any significant neurologic or psychiatric issues. The patient came with a good demeanor, was well-groomed, and was in a euthymic mood. Intelligence was surmised to be of above average range. The patient was able to sustain meaningful conversations. The mental status examination was also sound. No developmental issues were identified that could affect the neuropsychological maturity of the patient. Patient had good coping strategies and was found to be goal-oriented during the clinical interview.

Diagnosis: Unremarkable Neuropsychiatric and Psychological Evaluation

RECOMMENDATIONS

- 1. Upon closer look at his neuropsychiatric history, the patient has no premorbid personality that could preclude him from his planned employment as Instructor I in VSU-Baybay Campus.
- A careful neuropsychiatric examination did not reveal any unusuality in his personality, with the patient demonstrating good coping strategies to any challenges that he encounters as well as being goal-directed in his career.
- 3. Therefore, from a neuropsychiatric standpoint, he is deemed fit to work as a College Instructor.

Preliminary test results and recommendations were discussed with the patient upon completion of testing. He was open to the feedback and appreciative of the results.
