

## CONTRACT OF SERVICES

KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered into by and between:

The Visayas State College of Agriculture, an institution of higher learning established under Presidential Decree No. 470 as amended by Presidential Decree No. 700 with principal office at Baybay, Leyte, duly represented by the College President, SAMUEL S. GO, herein after referred to as the FIRST PARTY

- and -

NELITA P. GUYOS of legal age, Filipino single and residing at Guadalupe, Baybay herein after referred to as the SECOND PARTY:

### W I T N E S S E T H

WHEREAS, the FIRST PARTY is engaged not only in instruction but also in research and extension;

WHEREAS, the FIRST PARTY is a grantee of research funds from other government agencies such as PCARRD, NSDB, MA, and other private institutions;

WHEREAS, the FIRST PARTY is in need of personnel who possess the necessary technical know-how in the field of agricultural research to conduct researches or assist the researchers in the conduct of research activities;

WHEREAS, the SECOND PARTY possess the required technical know-how in agricultural research and willing to participate in any research and development activities;

NOW, THEREFORE, premises considered, the parties hereto have hereunto agreed on the following terms and conditions, to wit:

That the FIRST PARTY hires the services of the SECOND PARTY as Science Research Assistant in Project National Testing of Vegetables (Solanaceous) effective February 1, 1999 until June 30, 1999 unless sooner terminated;

That as the SECOND PARTY has the following duties and responsibilities:

1. Responsible in the establishment, care and maintenance of the project.
2. Gather, compile and collate data.
3. Make and submit reports.
4. Supervise laborers.
5. Other routine works that maybe assigned by the immediate supervisor.



That in consideration of the services of the SECOND PARTY, the FIRST PARTY binds itself to pay the former a total amount of Forty Eight Thousand Sixty Two Pesos and 74/100 representing salary including ACA & PERA for six months net of 15 days Service Break, payable at least twice a month at VISCA, Baybay, Leyte upon presentation of a certificate of service rendered duly attested by the representative of the FIRST PARTY;

That the SECOND PARTY authorizes the FIRST PARTY to deduct from the former's monthly salary the amount corresponding to personal contributions to GSIS term life insurance and medical insurance as provided by existing laws and regulations;

That the SECOND PARTY agrees to the reservation of a right of the FIRST PARTY to terminate the services of the former in the event that the performance of the SECOND PARTY is prejudicial to the smooth and efficient operation of the FIRST PARTY in achieving the purpose of the project, for lack of funds, or for other cause;

That in case either party desires to terminate this contract before its expiration date, a written notice shall be served to the other party at least (30) days before effectivity of the termination.
