That the SECOND PARTY has the following duties and responsibilities:

- 1. To assist the project leader on the following activities related to NRCCTP:
 - Conducting preliminary/advance trials to identify cultivars for entry in NRCCTP;
 - b. Setting-up of field for multiplication of materials in sweetpotato;
 - c. Setting-up and supervision of experiment in cooperating station throughout the Philippines; and

That the SECOND PARTY authorizes the FIRST PARTY to deduct from his/her monthly salary the amount corresponding to his/her personal contributions to GSIS, RLIP, Medicare, ECIP and PAG-IBIG is provided for by existing laws and regulations;

That the FIRST PARTY grants the SECOND PARTY reimbursement of actual and necessary expenses for travels made officially in connection with the project and duly
