

CONTRACT OF SERVICES
(Renewal)

KNOW ALL MEN BY THESE PRESENTS

This contract is made and entered into by and between:

The Visayas State College of Agriculture, an institution of higher learning established under Presidential Decree No. 470 as amended by Presidential Decree No. 700 with principal office at Baybay, Leyte, duly represented by the College President, DR. SAMUEL S. GO, hereinafter referred to as **FIRST PARTY**

and

DARIO P. LINA, of legal age, Filipino, Married and residing at Brgy. Guadalupe, Baybay, Leyte hereinafter referred to as **SECOND PARTY**

WITNESSETH

WHEREAS, the **FIRST PARTY** is engaged not only in instruction but also in research and extension activities;

WHEREAS, the **FIRST PARTY** is grantee of research funds from other government agencies such as PCARRD, NSDB, DA and other private institutions;

WHEREAS, the **FIRST PARTY** is in need of personnel who possess the necessary technical; knowhow in the field of agricultural research; to conduct researches or assist the researcher in the conduct of research activities;

WHEREAS, the **SECOND PARTY** possesses the required technical knowhow in agricultural research and willing to participate in any research and development activities;

NOW, THEREFORE, premises considered, the parties hereto have hereunto agreed the following conditions to wit:

That the **FIRST PARTY** hires the services of the **SECOND PARTY** as Sci. Res. Asst. in project VCO.40.0187.1298.074 entitled on the Development of self pollinating and precocious macapuno palms using three highly selfed dwarf coconut cultivars/hybrids effective January 1, 1998 until June 30, 1998 unless sooner terminated.

That the **SECOND PARTY** has the following duties and responsibilities:

- 1) To supervise laboratory and field activities
- 2) To gather and organize pertinent data
- 3) To assist the Study Leader in report preparation
- 4) To do other activities related to the conduct of the study

That in consideration of the **SECOND PARTY**, the **FIRST PARTY** binds itself to pay the former in the total amount of **FIFTY ONE THOUSAND THREE HUNDRED THIRTY SIX PESOS & .73 (P51,336.73)** representing salary including ACA and PERA for six months net of 36 days service break, payable at least twice a month at VISCA, Baybay, Leyte upon presentation of a certificate of service rendered duly attested by the representative of the **FIRST PARTY**

That the **SECOND PARTY** authorize the **FIRST PARTY** to deduct from the former's monthly salary the amount corresponding to personal contributions to GSIS term life insurance and medical insurance as provided by existing laws and regulations;

That the **FIRST PARTY** grants the **SECOND PARTY** reimbursement of actual and necessary expenses for travel made officially in connection with the project and duly authorized representative upon presentation of pertinent supporting papers and subject to usual accounting and auditing rules and regulations;


That the **SECOND PARTY** agrees to the reservation of a right of the **FIRST PARTY** to terminate services of the former in the event that the performance of the **SECOND PARTY** is prejudicial to the smooth and efficient operation of the **FIRST PARTY**, in achieving the purpose of the project, for lack of funds, or for other just cause;


That in case either party desires to terminate this contract before its expiration date, a written notice shall be served to the other party at least (30) days before effectivity of the termination.




