KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered into by and between:

The Visayas State College of Agriculture, an institution of higher learning established under Presidential Decree No. 470 as amended by Presidential Decree 700 with principal office at Baybay, Leyte, duly represented by the College President PACIENCIA P. MILAN, hereinafter referred to as the FIRST PARTY.

HAZEL I. BELLEZAS of legal age, Filipino, Single and resident at ViSCA, Baybay, Leyte hereafter referred to as the SECOND PARTY:

WITNESS ETH

WHEREAS, the FIRST PARTY is engaged not only in instruction but also in research and extension;

WHEREAS, the FIRST PARTY is a grantee of research funds from other government agencies such as PCARRD, NSDB, MA and other private institutions;

WHEREAS, the FIRST PARTY is in need of personnel who possess the necessary technical know-how in the field of agricultural research to conduct researches or assist the researchers in the conduct of research activities;

WHEREAS, the SECOND PARTY possess the required technical know-how in agricultural research and willing to participate in any research and development activities:

NOW, THEREFORE, premises considered, the parties hereto have hereunto agreed on the following terms and conditions to wit:

That the FIRST PARTY hires the services of the SECOND PARTY as Science Research Assistant in ODRD effective April 1 to December 31, 2000 unless sooner terminated:

That is the SECOND PARTY has the following duties and responsibilities:

1. Updates and maintains the R & D program database
2. Assists in the preparation of the College's R & D program budget proposal and development plans.
3. Assists in the preparation of the College's R & D program progress report;
4. Assists in the facilitation of R & D In-House Review and other related for a as well as in the preparation of proceedings.
5. Do other jobs may be assigned by superiors.

That in consideration of the services of the SECOND PARTY, the FIRST PARTY binds itself to pay the former a total amount of **EIGHTY TWO THOUSAND FOUR HUNDRED THREE PESOE & 02/100 (p 82,403.02)** only representing 9 months basic salary including PERA and ACA with 20 days service breaks payable at least twice a month at ViSCA, Baybay, Leyte upon presentation of the certificate of service rendered duly attested by the representative of the FIRST PARTY;

That the SECOND PARTY authorizes the FIRST PARTY to deduct from the former's monthly salary the amount of corresponding to personnel contributions for GSIS RLIP, Medicare, ECIP and PAG-IBIG premiums.

That the FIRST PARTY grants the SECOND PARTY reimbursement of actual and necessary expenses for travels made officially in connection with the project and duly approved by the FIRST PARTY or his duly authorized representative upon presentation of pertinent supporting papers and subject to usual accounting and auditing rules and regulations;

That the First Party shall be entitled to vacation and sick leave credits as prescribed for by MC 14, s. 1999. However, the FIRST PARTY shall use all leave credits earned within the year of service.




That in case either party desires to terminate this contract before its expiration date, written notice shall be served tot he other party at least thirty (30) days before effectivity of the termination.

IN WITNESS WHEREOF, we hereunto set our hands on this 1st day of April 2000 in ViSCA, Baybay, Leyte.




