WHO SHALL FILE

All public officials and employees, except those who serve in an honorary capacity, laborers and casual or temporary workers, shall file in three (3) copies under eath their Statements of Assets and Liabilities and Net Worth, Disclosure of Business Interests and Financial Connections including those of their spouses and unmarried children under eighteen (18) years of age living in their households, and Disclosure of Relatives in the Government. Married couples who are public officials or employees may file the required statements jointly or separately.

WHEN TO FILE

- 1. Within thirty(30) days after assumption of office, statements of which must be reckoned as of his first day of service;
- 2. On or before April 30 of every year thereafter, statements of which must be reckoned as of the end of the preceding years; or
- 3. Within thirty (30) days after separation from the service, statements of which must be reckoned as of his last day of office.
