

CONTRACT OF SERVICES
Renewal

KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered into by and between:

The Visayas State College of Agriculture, an institution of higher learning established under Presidential Decree No. 470 as amended by Presidential Decree No. 700 with principal office at Baybay, Leyte, duly represented by the College President, **DR. SAMUEL S. GO**, hereinafter referred to as the **FIRST PARTY**;

and

Antonieta C. Diaz of legal age, Filipino **Single** and residing at **Baybay, Leyte** hereinafter referred to as the **SECOND PARTY**:

W I T N E S S E T H

WHEREAS, the **FIRST PARTY** is engaged not only in instruction but also in research and extension activities;

WHEREAS, the **FIRST PARTY** is a grantee of research funds from other government agencies such as PCARRD, NSDB, MA and other private institutions;

WHEREAS, the **FIRST PARTY** is in need of personnel who possess the necessary technical know-how in the field of agricultural research to conduct researches or assist the researchers in the conduct of research activities;

WHEREAS, the **SECOND PARTY** possesses the required technical know-how in agricultural research and willing to participate in any research and development activities;

NOW, THEREFORE, premises considered, the parties hereto have hereunto agreed on the following terms and conditions, to wit:

That the **FIRST PARTY** hires the services of the **SECOND PARTY** as Computer Operator I in the Project Applied Tropical Ecology Program effective July 1, 1998 until December 31, 1998 unless sooner terminated;

That the **SECOND PARTY** has the following duties and responsibilities:

Computerization/word processing:

1. Typing/layouting of project reports, communications and project forms
2. Desktop publishing of reports and other articles

Databank/database maintenance:

3. Care and maintenance of all office-based computers and the databank system
4. In-charge of the project filing system of all project related documents

Other Assignments:

5. Participate in project related activities, does overtime work when necessary/requested and perform other functions the may be assigned by the management/supervisor from time to time.

That in consideration of the services of the SECOND PARTY, the FIRST PARTY binds itself to pay the former a monthly salary of **Eight Thousand Four Hundred Fifty Five and 20/100 (P8,455.20)** plus **ACA of P500.00** and **PERA of P500.00** per month payable at least twice a month at VisCA, Baybay, Leyte upon presentation of a certificate of service rendered duly attested by the representative of the FIRST PARTY;
6 months salary P50,731.20 + P6,000.00 representing ACA and PERA for 6 months.

That the SECOND PARTY authorizes the FIRST PARTY to deduct from the former's monthly salary the amount corresponding to personal contributions to GSIS term life insurance and medical insurance as provided by existing laws and regulations;


That the SECOND PARTY agrees to the reservation of a right of the FIRST PARTY to terminate the services of the former in the event that the performance of the SECOND PARTY is prejudicial to the smooth and efficient operation of the FIRST PARTY in achieving the purpose of the project, for lack of funds, or for other just cause;

That in case either party desires to terminate this contract before its expiration date, a written notice shall be served to the other party at least thirty (30) days before effectivity of the termination.




