Now, THEREFORE, premises considered, the parties hereto have hereby agree as they have agreed under the terms and conditions, as follows:


THAT the SECOND PARTY hereby undertakes the afore-mentioned job under the direct supervision of the FIRST PARTY or his duly authorized representative:


