WHEREAS, the Visayas State College of Agriculture has to promote  
staff development through faculty Scholarship, Fellowship or Financial  
Assistance for graduate/post graduate work in major fields of speciali-  
zation;

WHEREAS, the GRANTEE has fully and satisfactorily met all the

Monbusho Scholarship grant;

NOW, THEREFORE, for and in consideration of the mutal stipulations  
and conditions hereinafter contained, the parties do hereby agree as  
follows:

hereby accepts a Monbusho Scholarship grant  
to be effective on April 1, 1996  
and to terminate on March 31, 1997  
subject to renewal upon recommendation of the ViSCA  
Scholarship Committee and compliance with the perti-  
nent provisions of this Contract for the completion  
of a Ph.D.  
course/degree in Agricultural Engineering (Crop  
Processing)  
to be pursued by the Grantee pursuant to and by virtue  
of this award, unless otherwise terminated earlier in  
accordance with this covenant. In case of an approved  
renewal or extension of his/her Scholarship Grant  
beyond the period specified in this Contract, there  
shall be no more necessity for another instrument to  
be drawn.
2. The GRANTEE agrees and binds himself/herself to:
  - a. Pursue a Ph. D.  
course/degree in Agricultural Engineering  
(Crop Processing)  
for which this award is granted in the HOKKAIDO University (Language)  
and at the QBIHIRO UNIVERSITY (Research)
  - b. Conduct himself/herself in not to bring  
disgrace or dishonor in himself and/or his  
country;
