

CONTRACT OF SERVICES  
Renewal

KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered into by and between:

The Visayas State College of Agriculture, an institution of higher learning established under Presidential Decree No. 470 as amended by Presidential Decree No. 700 with principal office at Baybay, Leyte, duly represented by the College President, **DR. SAMUEL S. GO**, hereinafter referred to as the **FIRST PARTY**;

and

**Marlito M. Bande** of legal age, Filipino **Single** and residing at **Brgy. Marcos, Baybay, Leyte** hereinafter referred to as the **SECOND PARTY**:

W I T N E S S E T H

WHEREAS, the FIRST PARTY is engaged not only in instruction but also in research and extension activities;

WHEREAS, the FIRST PARTY is a grantee of research funds from other government agencies such as PCARRD, NSDB, MA and other private institutions;

WHEREAS, the FIRST PARTY is in need of personnel who possess the necessary technical know-how in the field of agricultural research to conduct researches or assist the researchers in the conduct of research activities;

WHEREAS, the SECOND PARTY possesses the required technical know-how in agricultural research and willing to participate in any research and development activities;

NOW, THEREFORE, premises considered, the parties hereto have hereunto agreed on the following terms and conditions, to wit:

That the FIRST PARTY hires the services of the SECOND PARTY as Science Research Assistant I in the Project Applied Tropical Ecology Program effective July 1, 1998 until December 31, 1998 unless sooner terminated;

That the SECOND PARTY has the following duties and responsibilities:

1. Act as facilitator and resource person in the conduct of Rainforestation Farming Training in the province of Leyte;
2. Establish linkages with cooperatives and other line agency;
3. Assist in the procurement of materials to be used in the project site;
4. Organize local communities and strengthening its organizations on Rainforestation and assist in the development of a Rainforestation farming cooperator;
5. Assist Program Director in the monitoring of all Rainforestation Project of their progress and needs;
6. Perform clerical works as the need arises;
7. Prepare monthly/quarterly accomplishment report; and
8. Participate in project related activities and perform other duties that may be assigned by the management/supervisor from time to time.

That in consideration of the services of the SECOND PARTY, the FIRST PARTY binds itself to pay the former a monthly salary of **Nine Thousand Six Hundred Eighty and 40/100 (P9,680.40)** plus **ACA of P500.00** and **PERA of P500.00** per month payable at least twice a month at VisCA, Baybay, Leyte upon presentation of a certificate of service rendered duly attested by the representative of the FIRST PARTY;

**6 months salary P58,082.40 + P6,000.00 representing ACA and PERA for 6 months.**

That the SECOND PARTY authorizes the FIRST PARTY to deduct from the former's monthly salary the amount corresponding to personal contributions to GSIS term life insurance and medical insurance as provided by existing laws and regulations;


That the SECOND PARTY agrees to the reservation of a right of the FIRST PARTY to terminate the services of the former in the event that the performance of the SECOND PARTY is prejudicial to the smooth and efficient operation of the FIRST PARTY in achieving the purpose of the project, for lack of funds, or for other just cause;


That in case either party desires to terminate this contract before its expiration date, a written notice shall be served to the other party at least thirty (30) days before effectivity of the termination.

IN WITNESS WHEREOF, we hereunto set our hands on this **1st day of July 1998** in VisCA, Baybay, Leyte.




