## WIINESSETH:

WHEREAS, the Visayas State College of Agriculture has to promote staff development through faculty Scholarship, Fellowship or Financial Assistance for graduate/post graduate work in major fields of specialization;

WHEREAS, the GRANTEE has fully and satisfactorily met all the requirements as to qualification, standards and criteria set for the scholarship grant;

NOW, THEREFORE, for and in consideration of the mutual stipulations and conditions hereinafter contained, the parties do hereby agree as follows:

- c. Take a full academic load every semester without changing bear her fields of specialization without prior clearance from the GRANTOR;
- d. Conform to all rules, regulations and laws of the institution be she is attending and to such other regulations as may be duly prescribed by the GRANTOR in connection with the scholarship (summer)
- e. Retain the scholarship throughout the period unless compelled to withdraw for urgent reasons and upon approval of the GRANTOR; Accept no other kind of scholarship without clearance from Visca;
- f. Maintain a semestral grade point average acceptable to the graduate school;
- g. Return to Visca immediately upon termination/completion of bis/her studies or course under the grant; and submit a written report on bis/her studies within sixty (60) days after return to duty;
- Serve ViscA for a period of time at the rate of two years for every year or a fraction thereof not less than two months of enjoyment of the scholarship within the Philippines or at the rate of three years if enjoyed outside of the Philippines, less than two months of enjoyment of said grant shall be served for half the rate. Provided, that failure to comply with the provisions of this paragraph or willful abandonment of the grant before the completion thereof shall obligate the GRANTEE to reimburse immediately in full to the GRANTOR all the expanses that the latter or the Philippine Government may have incurred including transportation, salaries and other expenses related thereto as well as external financial grants given through or upon endorsement of the College in connection with the prant plus an equity charge equivalent to 100% of the total amount expended, which in case shall not be less than 15,000.00 and 14% interest per annum from the date of breach or revocation. It should be fully understood that proportionate refund shall in NO CASE be allowed.
- i. Submit a copy of the thesis manuscript to the ViSCA Library.
- 3. The GRANTEE shall forfeit or otherwise cease to be entitled to all benefits and privileges due king her under this Agreement and shall likewise be required to reimburse in the same manner herein specified should keeshe fail to meet, comply or observe any of the obligations stipulated hereby and for other causes within king her control like the following:
  - a. Withdrawal from the Contract either during the life of the grant or during the period within which the Grantee shall have to render service to the Grantor;
  - b. Optional retirement from the service;
  - c. Removal from the service for cause;
  - d. Revocation of the grant by competent authorfty on account of the Grantee's conduct or behavior prejudicial to the College interests.
