LSU FELLOWSHIP GRANT

KNOW ALL MEN BY THESE PRESENTS:

This agreement made and entered into by and between:

The Leyte State University (LSU) formerly the Visayas State College of Agriculture (ViSCA), an institution of higher learning established under Presidential Decree No. 470 as amended by Presidential Decree No. 700, and converted into a University by virtue of R.A. 9158 with principal office at Baybay, Leyte duly represented by the University President, Dr. Paciencia P. Milan, hereinafter referred to as the GRANTOR;

-and-

**ROSARIO A. SALAS** of legal age, Filipino, **married**, with residence and postal address at LSU Campus, Baybay, Leyte hereinafter referred to as the GRANTEE;

WITNESSETH

WHEREAS, the parties have executed an LSU Fellowship Grant to pursue a Doctoral degree in Horticulture in Leyte State University which was entered into as Doc. No. 16, Page No. 04; Book No. XIX, Series of 2006; of the notarial register of Atty. Gloriosa C. Guinocor;

WHEREAS, as part of the award, the Grantee shall spend the last two semesters of her study leave for the experimental part and manuscript preparation which will be done in UPLB and/or overseas in collaboration with AVRDC, The World Vegetable Center, Tainan, Taiwan;

NOW, THEREFORE, for and in consideration of the mutual stipulations and conditions hereunder contained, the parties do hereby agree as follows:

1. The Grantor shall allow the Grantee to conduct her dissertation to pursue the doctoral degree as agreed in the fellowship contract executed by the parties mentioned above at the AVRDC- The World Vegetable Center at Tainan, Taiwan from April 1, 2007 to March 31, 2008;
2. The GRANTEE agrees and binds herself to:
  - a. Conduct the dissertation activities and prepare her dissertation manuscript at AVRDC - The World Vegetable Center at Tainan, Taiwan from April 1, 2007 to March 31, 2008;
  - b. Conduct herself in a manner not to bring disgrace or dishonor to herself and/or her country;
  - c. Conform to all rules, regulations and laws of the Center and to such other regulations as may be duly prescribed by the Grantee in connection with this grant.
  - d. Retain the grant throughout the period unless compelled to withdraw for urgent reasons and upon approval of the GRANTOR;
  - e. Accept no other kind of Fellowship Grant and/or employment without clearance from LSU;

- f. Return to LSU immediately upon termination/completion of *her* dissertation and submit a report of her dissertation activities within sixty days from return to duty.
  - g. Serve LSU for a period of time at the rate of three years for every year or a fraction thereof not less than two months of enjoyment of this grant less than two months of enjoyment of said grant shall be served for half the rate. Provided, that failure to comply with the provisions of this paragraph or willful abandonment of the grant, resulting to the non-completion of the dissertation activities shall obligate the GRANTEE to reimburse immediately in full to the GRANTOR all the expenses that the latter or the Philippine Government may have incurred including transportation, salaries and other expenses related thereto as well as external financial grants given through or upon endorsement of the University in connection with *her* grant plus an equity charge equivalent to 100% of the total amount expended, in which case shall not be less than P 5,000.00 and 14% interest per annum from the date of breach or revocation. It should be fully understood that proportionate refund shall in NO CASE be allowed.
  - h. Pay back LSU the full amount spent for *her* grant if the GRANTEE fails to complete or finish the dissertation due to any of the following reasons: resignation, voluntary retirement or failure to meet the academic standards due to negligence and non-health reasons. Returning to LSU to serve the University without completing the degree shall not free the GRANTEE of her obligation to reimburse in full the amount spent of her grant;
  - i. Submit a copy of the thesis manuscript to the LSU Library.
3. The GRANTOR binds itself to pay;
- a. Salary
  - b. Stipend – P2,000/month
  - c. Book Allowance - P 5,000.00/semester
  - d. Thesis Support - P 30,000
  - e. School Fees
4. This additional contract specifically revised the earlier contract involving the service requirement from three years to two years per year of enjoyment of the grant.




