This Contract made and entered into by and between:

WITNESSETH

WHEREAS, the FIRST PARTY is engaged not only in instruction but also in research and extension;

WHEREAS, the FIRST PARTY is/grantee of research funds from other government agencies such as PCARRD, NSDB, MA, and other private institutions;

That the SECOND PARTY has the following duties and responsibilities:

- 3. To do other functions that may be assigned by his supervisor.
