TERMS OF REFERENCE

KNOW ALL MEN BY THESE PRESENTS:

This agreement made and entered into by and between:

The Visayas State University (VSU) formerly the Leyte State University (LSU), which was renamed from LSU to VSU by virtue of R.A 9437 with principal office at Baybay, Leyte, duly represented by the University President, **Dr. EDGARDO E. TULIN** hereinafter referred to as the **GRANTOR**;

-and-

DR. LIJUERAJ J. CUADRA of legal age, married, Filipino, with residence and postal address **Apt 2, Kilbourne ST., VSU, Visca, Baybay, Leyte** in hereinafter referred to as the **GRANTEE**;

WITNESSETH

WHEREAS, the Visayas State University has to promote and maintain its own merit system by encouraging its academic staff to study, investigate, undertake research on exchange professorship to improve staff competencies, efficiency and effectiveness through sabbatical assignment;

WHEREAS, the **GRANTEE** has fully and satisfactorily met all the requirements as to qualification, standards and criteria set for the sabbatical assignment;

NOW, THEREFORE, for and in consideration of the mutual stipulations and conditions hereinafter contained, the parties do hereby agree as follows:

1. Subject to the terms and conditions stated below, the University hereby awards to the **GRANTEE** and the latter accepts a **Sabbatical Leave** to be effective on **August 1, 2018 and to terminate on July 31, 2019** and in compliance with the pertinent provisions of this Agreement for the completion of the sabbatical assignment to be pursued to and by virtue of this award, unless otherwise terminated earlier in accordance with this covenant;
2. The **GRANTEE** agrees and binds himself to:
 - a. Pursue a sabbatical assignment for which this award is granted for one (1) year from **August 1, 2018 and to terminate on July 31, 2019** of which her leave will be spent in the university;
 - b. Submit to the OVPI thru the APB, the following outputs at the end of the Sabbatical period:
 1. A published professional education book entitled: "The Teacher and the School Curriculum" in collaboration with Cebu Normal University Professors. A Certification from the Editor/s-In-Chief indicating that such book has been accepted for publication if it is not yet off the press at the end of the sabbatical leave;

2. Write AgEd 212 (College Teaching) and AgEd 212 (Curriculum Development full-blown course wares for the VSU Open University.
3. A published article derived from the Graduate Tracer Study of VSU;
4. Publication outputs should be products of her own research and not those derived from the thesis of her students;
- c. Pay back VSU the full amount spent for *her Sabbatical Grant* if the **GRANTEE** fails to submit her sabbatical outputs at end the Sabbatical Leave.
- d. Serve VSU for a period of one (1) year after her sabbatical assignment;
- e. The **GRANTEE** shall forfeit or otherwise cease to be entitled to all benefits and privileges (including travel privileges charged to the university) due her under this Agreement and shall likewise be required to reimburse in the same manner herein specified should she fail to comply or observe any of the obligations stipulated herein and for other causes within her control such as the following:
 - e.1 Going on leave without pay after the end of her sabbatical leave;
 - e.2 Optional retirement from the service;
 - e.3 Removal from office for a cause; or
 - e.4 Revocation of the grant/privilege by competent authority on account of the Grantee's conduct or behavior prejudicial to the University interests.

3. The **GRANTOR** binds herself to pay salary and other benefits as provided by law for the duration of her sabbatical assignment.


