

Greetings.

This letter is a continuation of our ever-encountered problems at Cattleya Cottage. To put everything on the record, I have here again two incidents, which I think important now for the office of the university president to be aware of:

First, before the holy week, the left side of our vehicle's roof, which is made of "trapal", was cleanly slashed. Then on the day we left for Cebu for the holy week vacation, I inspected the vehicle and had parked it near Mr. Sedrome's unit. But unfortunately when we came back, it's now at the right side of the vehicle's roof that was slashed again, even if this portion is towards the side of the garage roof, which extends down to the ground. My question now is who did this since for almost three years my vehicle has been parking on that area and so far nothing happened such as this kind of vandalism. We did not report this incident to the security office since it is difficult to accuse anybody, not until we have experienced the second problem that could only be possibly done by a person without a heart, not mentally stable or maybe a person high on drugs.

The second incident was last Thursday, May 2, 2002. Before going home, my wife made a telephone call from my office to our niece at Cattleya Cottage at around 6:30 in the evening just before going home. Upon arriving we have seen one of the occupants of Cattleya Cottage setting under the caimito tree near our doorstep. After taking our supper, it was between 7:10 to 7:30 in the evening, my wife supposedly would make a long distance call to our family in Cebu but unfortunately there was " NO DIAL TONE". On the following day, we made a call to Globelines main office in Manila reporting our complain of no dial tone at the same time to Prof. Sergio Abit, Sr., our LSU Chief Security Officer. Between 3:30 to 4:00 in the afternoon of that same day, two engineers from the technical group of Globelines, Ormoc City came over to fix our telephone lines. Mr. Rito S. Codog, our LSU security guard on duty, as witness accompanied these men at Cattleya Cottage. As per findings of Engrs. Ymas and Mendoza, our telephone line was "INTENTIONALLY CUT". Their finding was then relayed to my wife who came over to meet these men near Guard Post No 1. They even mentioned to my wife that while they were fixing the telephone line, a woman came out complaining why the grounding rod was installed on that area. One of the engineers answered back quoted as: "It's because this is the ideal area where the grounding rod is nearest to the telephone unit. If you want to complain just file a letter to our company so that your request will be entertained". Then the engineer further asked: "Is this building

wn by a private person or are you the owner of this building?" Woman answered: "No its own by ViSCA". After the repair of our telephone line the engineers left the building.

It is my fervent hope that the administration would scrutinize and investigate those people who are liable to these wrong doings and possibly impose punishment due to them.
