Indications:

- This vaccine is intended for the vaccination of healthy cats and kittens as an aid in preventing feline viral rhinotracheitis (FVR) caused by feline herpesvirus-1, feline respiratory disease caused by feline calicivirus (FCV), feline panleukopenia (FPL) caused by feline panleukopenia virus and feline chlamydiosis caused by Chlamydomphila felis.

Dosage and Directions For Use:

- Use only as directed. Aseptically rehydrate the freeze-dried vaccine with the sterile diluent provided.

General Directions:

- Vaccination of healthy cats is recommended. Shake well. Aseptically administer 1 ml *subcutaneously* or *intramuscularly*.

Primary vaccination:

- Healthy cats 12 weeks of age or older should receive 2 doses, each administered 3 - 4 weeks apart. Cats vaccinated at less than 12 weeks of age should be revaccinated at 12 weeks of age.

Revaccination: Annual revaccination with a single dose is recommended.

Storage:

- Store between 2 °C and 7 °C. Do not freeze.

25 x 1 dose vials with 25 vials packed in a clear, plastic, flip top container with a package insert and lot number stickers included.

DESCRIPTION: RECOMBITEK® C6 contains a lyophilized suspension of a recombinant canarypox vector expressing the HA and F glycoproteins of canine distemper virus; modified live adenovirus type 2, parainfluenza virus, and parvovirus; and a liquid suspension of inactivated cultures of *L. canicola* and *L. icterohaemorrhagiae*. Safety and immunogenicity of this product have been demonstrated by vaccination and challenge tests in susceptible dogs.

INDICATIONS: RECOMBITEK® C6 is recommended for the vaccination of healthy dogs 6 weeks of age and older for prevention of disease due to canine distemper virus, canine parvovirus, canine adenovirus type 1 (canine hepatitis), canine adenovirus type 2 (canine respiratory disease complex), canine parainfluenza virus, and the bacteria *L. canicola* and *L. icterohaemorrhagiae*.

DOSAGE: Reconstitute the lyophilized vaccine with accompanying liquid diluent and aseptically inject 1 mL (1 dose) subcutaneously or intramuscularly into healthy dogs. For primary vaccination, revaccinate with a second 1 mL dose 2 to 3 weeks later. Dogs younger than 12 weeks of age should be revaccinated with a single 1 mL dose every 2 to 3 weeks, the last dose given at or over 12 weeks of age. Revaccinate annually with a single 1 mL dose.

PRECAUTIONS: Store at 2-7°C (35-45°F). Do not freeze. Use immediately after reconstitution. Do not use chemicals to sterilize syringes and needles. Burn container and all unused contents. Contains gentamicin as a preservative. It is generally recommended to avoid vaccination of pregnant dogs. In rare instances, administration of vaccines may cause lethargy, fever, and inflammatory or hypersensitivity types of reactions. Transient lethargy, as well as pain and swelling at the site of injection, may occur following use of this product. Treatment may include antihistamines, anti-inflammatories, and/or epinephrine, as directed by a veterinarian.
