A. The Certifying Body shall:


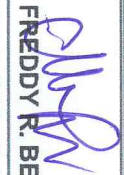

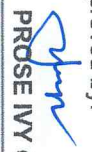
1. Provide its company profile highlighting related projects, scope of work and implementation methodology. Curriculum Vitae of the proposed audit team shall also be submitted;
2. Include in the proposal the audit activities and a procedure for client appeals. If resolution on good terms for disputes between the agency and the certification body cannot be made, the agency shall be afforded the right to lodge appeals about the decisions of the audit team through the Accreditation Body;
3. Conduct Audits on PCC at VSU's Quality Management System documentation based on ISO 9001:2015 that includes evaluation of the Center's location and site specific conditions, discussion with personnel, review of scope, processes and locations and applicable compliance obligations
4. Treat all reviewed and recorded information in the strictest confidentiality at all times;
5. Adhere to the agreed scope of work/ deliverables;
6. Provide a full report of audits consistent with the content of the approved scope of work/ deliverables to the agency at the end of each audit;
7. Accredited by the Philippine Accreditation Bureau (PAB) or any Accreditation Body for the relevant scope of the Center;
8. Deploy audit team composed of highly trained, impartial and experienced auditors knowledgeable of the agency's scope, or has a technical expertise for livestock research. Members of the audit team must have at least three (3) years of auditing experience in government agencies. No member of the audit team should have provided consultancy for the agency at least two (2) years prior to the audit;
9. Conduct audit base on the following Scope defined by the Philippine Carabao Center at Visayas State University; and
10. Issue certificate after passing the audit.
