A RESOLUTION ASKING THE LSU-BOARD OF REGENTS TO REPEAL AND MODIFY BOT RESOLUTION NO. 6, S. 2000

Whereas, said resolution granting free tuition fee to the CSSC officers, namely; President, V-President, Secretary, Treasurer, Auditor, and six (6) Senators effective S.Y 2000-2001, was duly approved based on the old structures of the CSSC prior for federation.

Whereas, such CSSC then as governed by old structure, was superseded upon the creation of a new student council that includes the external campuses which form part the federated University Supreme Student Council (USSC) composition.

Whereas, such changes expand the scope of the official family of the USSC and therefore can be entitled of the scholastic privileges being granted by the University for the student council officers.
