APRIL 22, 2016 TO APRIL 23, 2016 TO ATTEND THE INAUIGURAL PHILIPPINE
EDUCATION FAIR ORGANIZED BY THE PHILIPPINE EMBASSY IN
CAMBODIA AND THE COMMISSION ON HIGHER EDUCATION (CHED)
SUBJECT TO EXISTING RULES AND REGULATIONS GOVERNING
FOREIGN TRAVELS BY GOVERNMENT OFFICIALS

WHEREAS, the Philippine Embassy in Cambodia and the Commission on Higher Education (CHED) has organized the 1st Philippine Education Fair in Phnom Penh, Cambodia this coming 22 April 2016 to 23 April 2016;

WHEREAS, the CHED will be sending an official delegation composed of representatives of selected Higher Education Institutions (HEIs) and CHED officials;

WHEREAS, VSU President Edgardo E. Tulin has been invited to be part of the CHED delegation to attend and participate in the Education Fair as well as engage in sideline meetings with potential partner institutions in Cambodia;

WHEREAS, the VSU, Dr. Edgardo E. Tulin is requesting that he be allowed to travel to Phnom Penh, Cambodia to attend the Inaugural Philippine Education Fair in Phnom Penh for the period 20 April 2016 until 23 April 2016;

WHEREAS, the Visayas State University (VSU) will be bringing education and communication materials (IEC) as well as general information about the University, its program offerings for display and distribution during the Education Fair;

WHEREAS, all expenses attendant to President Tulin's travel to Cambodia will be borne by the Commission on Higher Education (CHED).
