**A RESOLUTION APPROVING THE PROPOSED STUDENT SERVICES PROGRAM  
OF THE UNIVERSITY STUDENT SERVICES OFFICE OF THE VISAYAS STATE  
UNIVERSITY**

**WHEREAS**, the Visayas State College of Agriculture (ViSCA) converted into the Leyte State University (LSU) by virtue of Republic Act 9158 last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 7, Paragraph (a) of R.A. 9158 empowers the Board of Regents of the University "*to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University*";

**WHEREAS**, the University Student Services Office (USSO) is the frontline office created to plan, coordinate, supervise and evaluate programs and services that concern the students' welfare, development and assistance;

**WHEREAS**, the USSO complements the instructional program of the University outside the classroom for the growth of the students in terms of personal, emotional, academic, spiritual and vocational life;

**WHEREAS**, the USSO is also the channel of communication which communicates and interprets the needs of the students to the University officials and in turn is expected to communicate and interpret the wishes of the University to the students;

**WHEREAS**, the other essential student services and programs are delivered by other units of the University, such as: a) basic health services – VSU Hospital; b) food services – Pavilion/Guest House and IGPO; c) safety and security services - University Security Force; d) foreign student services - International Student Office; e) sports programs – Institute of Human Kinetics; f) culture and arts programs - Center for Arts and Culture; g) student publication – Amaranth.

**WHEREAS**, the proposal was discussed and approved on the occasion of the 121<sup>st</sup> UADCO Meeting held last 24 August 2016 at 1<sup>st</sup> Floor, Center for Continuing Education (CCE), VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal for Approval by the VSU Board of Regents.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the proposed Student Services Program of the University Student Services Office (USSO) of the Visayas State University.
