BOR RESOLUTION NO. 02, s. 2023

A RESOULTION COURSED THROUGH REFERENDUM APPROVING THE TRAVEL OF MR. MARK GIL VEGA TO ATTEND THE "ASIAN CONFERENCE ON EDUCATION AND INTERNATIONAL DEVELOPMENT" ORGANIZED BY THE INTERNATIONAL ACADEMIC FORUM (IAFOR) ON MARCH 27-30, 2023 SUBJECT TO EO 77, S. 2019 ENTITLED: PRESCRIBING RULES AND REGULATIONS AND RATES OF EXPENSES AND ALLOWANCES FOR OFFICIAL LOCAL AND FOREIGN TRAVELS OF GOVERNMENT PERSONNEL

WHEREAS, Republic Act 9158 converted the then Visayas State College of Agriculture (ViSCA) into a state university, the Leyte State University, on 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7, Paragraph (b) of R.A. 9158 empowers the Governing Board "to receive and appropriate all sums as may be provided for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University";

WHEREAS, Visayas State University (VSU) supports its faculty and staff to do significant research related to their work and fields of specialization and present the outputs of their study in legitimate national and international research fora;

WHEREAS, Mr. Mark Vega is engaged in a study on indigenous health care and would present to an international audience an output of a VSU Research Project;

WHEREAS, funding from the travel would be sourced out from funds of the Faculty Development Program of the university;

WHEREAS, the proposal was endorsed by the University Administrative Council through referendum on 24 February 2023 to the VSU BOR Administrative and Academic Committee for the Committee's endorsement to the Full Board for approval;

WHEREAS, the proposal was endorsed with a recommending approval by the VSU Scholarship and Fellowship Committee to the Full Board for approval.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED approve the travel of Mr. Mark Gil Vega to attend the "Asian Conference on Education and International Development" organized by the International Academic Forum (IAFOR) on March 27-30, 2023.
