### BOR RESOLUTION NO. 138, s. 2017

A RESOLUTION CONFIRMING THE NEW TEMPORARY APPOINTMENT OF MS. ANGELIE E. MARILLA, VSU MAIN CAMPUS, EFFECTIVE ON THE DATE INDICATED IN HER APPOINTMENT AND SUBJECT TO EXISTING POLICIES, RULES AND GUIDELINES ON SUCH APPOINTMENT

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, Section 7, Paragraph (g) of R.A. 9158 empowers the Governing Board "to appoint, upon the recommendation of the President of the University, vice-presidents, deans, directors, heads of department, faculty members and other officials and employees of the University";

WHEREAS, the College Deans through the Vice President for Academic Affairs have recommended the issuance of new appointment under Temporary Status on Ms. Angelie E. Marilla:

WHEREAS, University Academic Personnel Board (APB) has gone over the qualifications of Ms. Angelie E. Marilla and has recommended to the University President the issuance of a new appointment (temporary status) on Ms. Angelie E. Marilla; and

**WHEREAS**, University President has reviewed the qualifications of Ms. Angelie E. Marilla and is favorably recommending to the Board of Regents the Confirmation of the new appointment *subject to* existing rules, regulations and guidelines governing such appointments.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to confirm the new appointment under Temporary Status on Ms. Angelie E. Marilla, effective on the date indicated.

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437:

WHEREAS, the Academic Personnel Board (APB) undertook a process of screening the most qualifications of the candidates for permanency following the requirements set by the ViSCA Code and in the NBC 461 Guidelines;

WHEREAS, after due deliberation, the APB determined that the three (3) faculty members possess the necessary qualifications for permanency, as follows:
