BOR RESOLUTION NO. 113, s. 2016

WHEREAS, Section 7, Paragraph (j) of R.A. 9158 empowers the Governing Board "*to set policies on admission and graduation of students*";

WHEREAS, Section 11 of Republic Act No. 9158 – The Academic Council - stipulates the powers of the Academic Council to wit: "*... review and recommend curricular offerings and fix the requirements for the admission to the University, as well as for graduation and the conferment of degrees, subject to the approval of the Board...*";

WHEREAS, the list of candidates for graduation from the different campuses of the VSU System for the 1st Semester, SY 2016-2017 was presented to the University Academic Council through a Referendum dated 22 November 2016, for review;

WHEREAS, the University Academic Council approved the List of Candidates for Graduation for the 1st Semester, SY 2016-2017, VSU System by way of Referendum and is strongly endorsing the List of Candidates for Graduation to the VSU Board of Regents for Confirmation, *Provided that*, all the candidates shall have complied with all of the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2016-2017.






